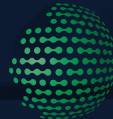


## EVENT SPONSHORSHIP AGREEMENT

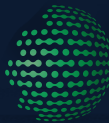
These Event Sponsorship Agreement General Terms and Conditions are attached, signed by Data Connectors I, Inc. (the “Company”) and the Participant named therein, and govern the event described therein (the “Event”).

1. **Access to Event Information:** The Participant shall not be entitled to any of the materials, registration information, lead retrieval, etc. for any Event unless the Participant participates in such Event, either directly or by a duly appointed representative that has been approved by the Company in writing in advance of the Event.
2. **Event Exhibit Space:** The Company shall provide the Participant with access to create its own booth environment in each of the Events listed in the applicable Addendum. All guidelines and rules for exhibit booths in all Events shall be in accordance with the specific policies and procedures of the venue hosting an Event. Failure by the Participant to utilize the exhibit space provided by the Company at an Event, whether virtual or physical, shall not entitle the Participant to receive a refund of any portion of the full sponsorship fee or to terminate its obligation to pay the full sponsorship fee.
3. **Event Speaking Sessions:** Speaking sessions will be assigned by the Company. The Participant may request a specific speaking session time but all decisions on such requests shall be made by the Company in its sole discretion.
4. **Payment Terms:** Payment in US Dollars of 25% of the full amount due with respect to each Event selected by the Participant shall be paid within 15 days of the execution of the Agreement. The remaining 75% of the full amount due for each Event shall be paid 60 days prior to the Event date. Payments may be made by credit card, check, ACH, or wire transfer in the US. If the Participant is not a US resident or domestic entity, all payments must be made in US Dollars.
5. **Cancellation of Event by the Company:** Subject to paragraph 6 below, if an Event is cancelled by the Company the Participant’s remedy may include a credit for a future event, or the return of the Participant’s payment for the affected Event. The Participant is not entitled to any further relief or damages.
6. **Force Majeure:** “Force Majeure” shall mean, with respect to either Party, any circumstances or causes beyond the reasonable control of such Party, including, but not limited to, any act of God, threat or act of terrorism, civil disturbance, war, riot, natural disaster, flood, fire, epidemic or other public health emergency, court order, actions by federal, state or local governmental authorities, labor stoppages or disputes, or failure or disruption of electrical, telecommunications, or other utilities. The Company shall not be liable for any prevention or delay in the performance of any Event, whether physical or virtual, resulting in whole or part, directly or indirectly, from Force Majeure affecting the Company. The Participant will not be responsible for impossibility of its sponsorship of any Event under the Agreement if such impossibility is due solely to Force Majeure affecting the Participant. Both Parties agree to reasonable negotiations prior to invoking Force Majeure under this paragraph 6.





7. **No Refunds or Cancellation for Events:** The Company relies upon the Participant's fees in obtaining and securing the Venue and materials for physical Events. Accordingly, except as specifically provided in paragraph 6 of the Agreement for cancellation of an Event by the Company, the Company will provide no refunds and permits no cancellations by the Participant, even for Force Majeure as affecting the Participant. The Company may, in its discretion, grant the Participant credit toward sponsorship of an Event at another Venue.
8. **Data Handling, Protection, and Compliance:** Participant is responsible for compliance with applicable data protection and privacy laws (including any relating to direct marketing by electronic means) in respect of personal data obtained from the Company, and/or from individuals participating in the Company's Events. Subject to such laws, the Participant is allowed to email those individuals on the event registration list twice to request consent for marketing communications. Intentional violation of any of this provision will result in the cancelation of existing contracts, and forfeiture of deposits or payments made by Participant related to contracted Events not yet conducted.
9. **Sponsorship Approval:** All sponsorship activities and promotions are subject to advance written approval by the Company, which the Company may grant or withhold in its sole judgment. The Company reserves the right to restrict, prohibit, or remove any person, activity, material, or promotion by the Participant which becomes objectionable, may detract from the general character of the Event, or may bring the Company, its business, or its personnel into disrepute, in each case as determined by the Company in its sole judgment. Sponsored speaking spots must have substantive educational content related to cyber security. Speakers may describe a security issue that their company's products address but the means by which their solution mitigates a security issue is to be explained in the "Solutions Showcase" exhibit areas.
10. **Participant Name, Logo, and Promotional Video Content:** The Participant shall provide the Company with a version of the Participant's logo in .jpeg or .png format. The Participant grants to the Company the royalty-free right to use the Participant's name, logo, promotional video, and any other materials presented in the Company's marketing materials.

12. **Governing Law:** The Agreement is governed by and is to be construed and enforced in accordance with the laws of the State of Missouri, without regard to its choice of law provisions.
13. **Severability:** If any provision of the Agreement is held to be invalid or unenforceable, it will be construed to have the broadest interpretation which would make it valid and enforceable. Invalidity and unenforceability of one provision will not affect any other provision of the Agreement.
14. **Notice:** The Participant shall follow the instructions provided by the Company with respect to any communications with the Company. Notices to the Participant by the Company may be made through the contact information of the Participant set forth on the signature page.



15. Counterparts and Electronic Signatures: The Agreement may be executed in multiple counterparts, each of which shall be deemed an original but all of which shall constitute one and the same instrument. The signed counterparts of the Agreement may be executed and delivered by facsimile, email or other electronic transmission by either Party to the other Party. The signature of each counterpart so executed and delivered shall be deemed to an original signature for all purposes under the Agreement and the receiving Party may rely on the receipt of such document so executed and delivered as if the original had been received.
